**BUSINESS DEVELOPMENT:** Small business is a priority. We know that support is needed now and that the journey to recovery will take some time. We are here to help:

- 1. Working with our existing affected clients to provide payment relief, additional funds as needed.** Please, if we haven't already spoken to you yet, contact our office.
- 2. Those who need help who are not already established clients-** we invite any affected business that may need our services to contact us. **We are providing loans for cash flow, inventory, repairs etc. The process is simple – if you have a need contact us, we will do our best to accommodate you as quickly and efficiently as possible.**

**COMMUNITY ECONOMIC DEVELOPMENT (CED):** At this time, we would like everyone in the region to know that we are actively advocating for assistance at all levels of government and are talking with community and regional stakeholders about the devastation we have experienced. We will be submitting a proposal very shortly to access funding for a Business Recovery Program and are managing and promoting a Go Fund Me Account and an account at the Grand Forks Credit Union for community donations. We will be working closely with the Boundary Country Regional Chamber of Commerce and the Grand Forks Downtown Business Association to provide assistance with members wherever possible and are here to help businesses distribute information.
